Dear Ms. Dreyfuss:

On July 28, 2020, our office received notification of a vacancy on the Rio Hondo Community College District (CCD) governing board resulting from the resignation of Ms. Norma Edith Garcia in Trustee Area 1, to be effective July 8, 2020. Under Education Code (EC) §5090 and Government Code §1770, July 28, 2020, the date the County Superintendent was notified, is the effective date of the vacancy.

## **Provisional Appointment**

In accordance with EC §5091(a), the Rio Hondo CCD governing board has **60** days from the date of the vacancy by which to make a provisional appointment to fill the remainder of Ms. Garcia's term in Trustee Area 1, which expires in December 2022.

If the governing board chooses to make an appointment, the deadline is **September 26, 2020**. If an appointment is made, please ensure that the provisions of EC §5092 are adhered to regarding posting and publication requirements. A provisional appointment confers all powers and duties of a governing board member upon the appointee **immediately** following his/her appointment.

## **Special Election**

If the governing board chooses not to make an appointment to fill the remainder of this term, there will not be an opportunity to hold a consolidated special election in line with the November 3, 2020 regularly scheduled general election due to the timing of the vacancy. Therefore, absent an appointment, the only opportunity to hold a special election would be on the March 2, 2021 state election date.
